

GPULib ACADEMIC USE SOFTWARE LICENSE AGREEMENT

0. RECITALS.

- (a) This Tech-X Corporation Academic License Agreement for GPULib Software (“Agreement”) is a legal agreement between you and Tech-X Corporation (“Tech-X”) for the use of the GPULib Software (the “Software”). If you are installing the software for personal use, this agreement applies to and binds you personally. If you are installing the software as part of your work for an organization, this agreement applies to and binds such organization. “LICENSEE” or “YOU” and “YOUR” refer to the person or entity that is licensee of the software.
- (b) By installing, copying, or otherwise using the Software or any work derived from the Software, Licensee accepts this Agreement, and agrees to be bound by all of its terms and conditions. No rights are granted to the Software except as expressly set forth herein. Nothing other than this Agreement grants Licensee permission to use, copy or modify the Software or any work derived from the Software. If Licensee does not accept the terms and conditions of this Agreement, it should not use, copy or modify the Software.

1. GRANT OF LICENSE

- (a) **License to Use.** Subject to the terms and conditions of this Agreement, Tech-X grants Licensee a worldwide, non-exclusive, non-transferable, non-sublicenseable right and license during the term of this Agreement to access and use the GPULib Software and all associated source code, examples, user manuals and documentation (collectively, the “Software”) on a single computer, running a single operating system, as set forth below for internal use by an academic institution only during the applicable term of this Agreement. Such use is limited to (i) student instruction or projects, (ii) demonstration, for the purposes of scientific or engineering education, or (iii) research purposes provided that such use is in no way commercial. For the purposes of this Agreement, an academic institution is any organization (school, college, university, or similar entity) that confers academic degrees or diplomas.
- (b) **Archival or Backup Copies.** Licensee is permitted to create one copy the Software for backup and archival purposes, provided that the original and such copy are kept in Licensee’s possession and that Licensee’s installation and use of the Software does not exceed that allowed in the “License Grant” section above. Licensee is not permitted to transfer any backup copies to third parties.
- (c) **License to Create Derivative Works.** Developers may create works derived from the Software.
- (d) **License to Distribute Software.** Tech-X Corporation grants to the Licensee a non-exclusive right to distribute the GPULib libraries in object code form solely for use in Licensee’s Derivative Works. Licensee may not resell GPULib in an unaltered form.

2. RESTRICTIONS

All rights not explicitly granted to Licensee are reserved by Tech-X. Without limiting the foregoing, Licensee will not:

- (a) Copy the Software except to make archival or backup copies as provided above,
- (b) Modify or adapt the Software,
- (c) Reverse engineer, disassemble, decompile or make any attempt to discover the source code of the Software,
- (d) Use any portion of the Software in a manner that doesn’t comply with applicable law, regulations, or governmental orders including, without limitation, all applicable privacy laws;
- (e) Export or re-export the Software

Upon Tech-X’s request, Licensee will provide assurances that it is using the Software in accordance with the terms of this Agreement.

3. OWNERSHIP

- (a) GPULib is solely owned by Tech-X Corporation. Tech-X has the right to license the Software for any other purpose.
- (b) All title and copyrights in and to the Software, including but not limited to any images, photographs, databases, animations, video, text and “applets” incorporated into the Software, any accompanying printed or electronic materials, and any copies of the Software, are owned by Tech-X, subject only to the licenses expressly granted to Licensee herein. This Agreement does not provide Licensee with title or ownership of

the Software, but only a revocable license of limited use. The Software is protected by copyright laws and international copyright treaties, as well as other intellectual property laws and treaties.

4. PRICES AND PAYMENT

For academic use (as defined above), GPULib is provided with no applicable license fees. Should use of GPULib result in a commercial derivative work or should use of GPULib transition to an entity that does meet the definition included herein for an academic institution, Licensee is required to contact Tech-X for the purpose of converting to the appropriate GPULib license agreement for non-academic use of the software.

5. NO WARRANTIES

TECH-X MAKES NO, AND HEREBY EXPRESSLY DISCLAIMS ANY AND ALL, WARRANTIES FOR THE SOFTWARE. THE SOFTWARE IS PROVIDED TO LICENSEE "AS IS," WITHOUT WARRANTY OF ANY KIND, EITHER EXPRESS OR IMPLIED, INCLUDING, WITHOUT LIMITATION, THE IMPLIED WARRANTIES OF MERCHANTABILITY, FITNESS FOR A PARTICULAR PURPOSE AND NONINFRINGEMENT. THE LICENSEE BEARS THE ENTIRE RISK AS TO THE USE, QUALITY AND PERFORMANCE OF THE SOFTWARE. LICENSEE EXPRESSLY ASSUMES THE COST OF ALL NECESSARY SERVICING, REPAIR OR CORRECTION, SHOULD THE SOFTWARE PROVE DEFECTIVE.

6. LIMITATION OF LIABILITY

IN NO EVENT WILL TECH-X CORPORATION BE LIABLE FOR ANY GENERAL, DIRECT, INDIRECT, INCIDENTAL, SPECIAL OR CONSEQUENTIAL DAMAGES WHATSOEVER (INCLUDING, WITHOUT LIMITATION, DAMAGES FOR LOSS OF BUSINESS PROFITS, BUSINESS INTERRUPTION, INACCURATE INFORMATION, LOSS OF INFORMATION, OR ANY OTHER PECUNIARY LOSS) ARISING OUT OF THE USE OR INABILITY TO USE THE SOFTWARE, EVEN IF TECH-X CORPORATION HAS BEEN ADVISED OF THE POSSIBILITY OF SUCH DAMAGES. NOTWITHSTANDING ANYTHING IN THIS AGREEMENT, IN NO EVENT SHALL TECH-X'S AGGREGATE LIABILITY ARISING UNDER, WITH RESPECT TO OR IN CONNECTION WITH THIS AGREEMENT EXCEED THE TOTAL AMOUNTS PAID BY LICENSEE TO TECH-X UNDER THIS AGREEMENT.

7. U.S. GOVERNMENT RESTRICTED RIGHTS

If Software is being acquired by or on behalf of the U.S. Government or by a U.S. Government prime contractor or subcontractor (at any tier), then the Government's rights in Software and accompanying documentation will be only as set forth in this Agreement; this is in accordance with 48 CFR 227.7201 through 227.7202-4 (for Department of Defense (DOD) acquisitions) and with 48 CFR 2.101 and 12.212 (for non-DOD acquisitions). The manufacturer is Tech-X Corporation, 5621 Arapahoe Avenue, Suite A, Boulder, Colorado 80303.

8. TERM AND TERMINATION

- (a) This Agreement commences when the Software is installed, copied, or otherwise used and will continue for the applicable term unless earlier terminated as provided in this Section 8. This Agreement may be terminated: (a) at any time upon mutual written agreement of Licensee and Tech-X; or (b) by Tech-X, by written notice to Licensee if Licensee (i) breaches a material obligation under this Agreement and such breach continues uncorrected for a period of thirty (30) calendar days after notice in writing thereof to an authorized representative of Licensee, or (ii) if Licensee fails to pay an amount due hereunder and continues to be delinquent for thirty (30) calendar days; or (c) by Licensee for convenience, provided Licensee provides thirty (30) calendar days' notice of the intended termination date, or (d) by either Party, if the other Party becomes insolvent or is adjudged as bankrupt; makes an assignment for the benefit of creditors; has a receiver appointed; or files a petition of bankruptcy. The licenses granted under this Agreement are subject to 11 U.S.C. §365(n).
- (b) Effect of Termination; Survival. Upon termination of this Agreement, Licensee will immediately (i) cease any and all use of the Software, (ii) delete the Software from its systems; and (iii) and will destroy any and all of copies of the Software and any work derived from the Software. Sections 2, 3, 5, 6, 9, and 11-15 will survive termination of this Agreement.

9. CONFIDENTIALITY

The structure, organization, and code of the Software are the valuable trade secrets, know-how and proprietary and confidential information of Tech-X and its licensors (“Confidential Information”). Licensee will use best efforts to maintain the confidentiality and security of the Confidential Information and prevent the unauthorized disclosure or use of such Confidential Information. Licensee will disclose Confidential Information only to employees or contractors of the Licensee who need access to such Confidential Information in order to support Licensee’s authorized use of the Software after Licensee has required such employees and contractors to execute a written agreement, to protect Confidential Information as provided in this Agreement. Licensee will notify Tech-X immediately if it learns of a current or threatened misuse or unauthorized use or disclosure of the Software and will cooperate with Tech-X in its efforts to resolve such misuse. ANY USE OR DISCLOSURE OF THE CONFIDENTIAL INFORMATION MAY BE ACTIONABLE AS A VIOLATION OF TECH-X’S PROPRIETARY, CONFIDENTIALITY, OR TRADE SECRET RIGHTS.

10. SERVICE AND SUPPORT

The service and support that Tech-X offers for the Software under this Agreement are limited to the service or support, if any, that is described on Tech-X’s website.

11. INDEMNIFICATION

Licensee will defend, indemnify, and hold harmless Tech-X, its affiliates, directors, licensors, employees, and agents harmless from and against any claim, action, proceeding, loss, cost, expense, damages, and liability, including reasonable attorneys’ fees, arising from: (1) Licensee’s use or other actions relating to the Software and/or (2) Licensee’s breach of any provision of this Agreement.

12. GOVERNING LAW

This Agreement shall be governed and construed in accordance with the laws of the State of Colorado, without regard to any applicable conflicts of law provisions thereof that may require the application of the laws of another jurisdiction.

13. DISPUTE RESOLUTION

To the extent Licensee has in any manner violated or threatened to violate Tech-X’s and/or its licensor’s intellectual property rights, Tech-X and/or its affiliates may seek injunctive or other appropriate relief in any state or federal court in the State of Colorado. Licensee consents to exclusive jurisdiction and venue in the appropriate state or federal court in the State of Colorado in the event of any litigation regarding this Agreement.

14. ASSIGNMENT

Licensee is not permitted to transfer this Agreement or any of the rights granted by it, including assignments or transfers by operation of law, as well as by contract, merger or consolidation. This Agreement is binding upon and inure to the benefit of Tech-X, Licensee and their permitted successors.

15. GENERAL PROVISIONS

- i. This Agreement is the exclusive agreement between Licensee and Tech-X concerning the Software and may be modified only by a writing signed by Licensee and Tech-X.
- ii. If any part of this Agreement is found invalid, such invalidity will not affect the validity of remaining portions of this Agreement, and the parties will promptly substitute for the invalid provision a provision that most closely approximates the intent and economic effect of the invalid provision.
- iii. In the event of litigation between Licensee and Tech-X concerning the Software, the prevailing party in the litigation will be entitled to recover attorney fees and expenses from the other party.

- iv. The Software licensed hereunder is subject to the export licensing regulations of the United States. Licensee agrees that the Software will not be shipped, transferred or exported into any country or used in any manner prohibited by the United States export laws, restrictions or regulations.
